Sir,

I am directed to refer to the above subject and to state for removal of doubts that post facto conversion made before 07/11/2017 of land not exceeding 0.03 acre of land, other than any plot of land having water body of any description or size, falling within the local limit of any Municipal Corporation or Municipality and 0.08 acres of land, other than any plot of land having water body of any description or size, falling not within the local limit of any Municipal Corporation or Municipality may be processed and disposed of under an application in form (1C) as prescribed in sub-rule (1) of rule 5AA of the West Bengal Land Reforms Rule, 1965 and on payment of fees in cases, considered eligible for regularisations, as prescribed in sub-rule (6) of rule 5AA of the said rule as already directed in this Department's Circular No.2222-LP dated 21/06/2018.
