- (c) Minimum area of land required to be kept as open space for enjoyment of such building as per building regulations or 500 sq.m., whichever is less:
- (d) Whether any building was constructed before the 28th January 1976 with a dwelling unit: if so, the extent of open space contiguous to the open space referred to in (c) above:
