Sub: Symposium on Departmental Works.

Respected Sir,

As a responsible organization of the departmental cadre, we are not only answerable to our cadres for raising of our demands for better service condition, due time promotion and legitimate transfer etc. but also for our responsibility to enhance our skill by organizing workshops and symposiums for up-skilling and re-skilling the cadres, to serve the co-citizens of the State, more efficiently.

We have observed that in the prevailing socio-economic biome, even after the evolution of the infrastructure and departmental services in various fields, such as e-Bhuchitra modules, Land management system etc., there remains a wide gap between the demand and the expected service delivered in time, from our department's end.

There are various reasons for the same, such as the lack of officials due to long standing vacancies, inadequate infrastructure, improper implementation of the Government's flagship projects etc. On the other hand, the lack of experience and knowledge sometimes compels the officers to make unintentional mistakes raising the eyebrows of the law and order enforcing authorities and judicial forums which occasionally results in media trials. In such a situation, we feel the urge to pull up the socks of the officials in order to brighten the image of the officials of the L&LR and RR & R Department.

With this august vision, we recently, organized two symposia cum workshop at two citadels of our State, one at Siliguri, held on 13/09/2025 and the other in Kolkata, on 01/11/2025. In both the occasions, we have made our focus upon the contemporary subjects in tune with the Government policy for citizen centric works, legal procedures as well as to augment revenue generation, for the State exchequer. In spite of the busy schedule, extreme workload of the vulnerable urban and semi-urban block offices, the Revenue Officers, the SRO-IIIs and other Officers of the department, along with other officials at block level, have overwhelmingly supported our endeavour, and attended both the sessions of our workshop which is honestly, beyond our expectations. We have felt that the

officials are in desperate need to update their knowledge and skill, to serve in a much better and efficiently.

We also feel that the department should consider of organizing retraining along with hands on training, throughout the year, on a regular basis.

With our limited resource, we have shared our available expertise and rubbed shoulders with our brethren. Our association would like to continue such effort in future, to refurbish our excellence. This effort may help the officials to raise their head in pride to discharge their duties. It is needless to mention here that we also organize virtual workshops on regular basis.

Such small efforts of our association have also got the attention of the media. The english daily newspaper like The Statesman dated 15/09/2025, The Times of India, dated 07/11/2025 and bengali daily newspaper Ei Samay, dated 08/11/2025, have reported upon our initiatives. (Copy enclosed)



The Association of Land and Land Reforms Officers, West Bengal, organised a symposium in Kolkata under the theme 'Agility and Exchanges of Views Will Make It Happen'. It focused on three areas — e-Bhuchitra and related aspects, land tribunal related matters and minor minerals with special emphasis on brick field modules — which are pertinent issues to the officers' working in the districts near Kolkata. The speakers delivered presentations on the respective topics. Participants from adjoining districts discussed how new digital tools, evolving policies and stricter enforcement measures could im-

prove management of land record with special reference to government land and resource management across the region. The session covered the new features of e-Bhuchitra, disputes arising in land tribunal and issues related to brick field management, fundamentals of powers to revenue officers, and the latest developments in enforcement. Focus was on Free Hold Title Deed (FHTD), compliance proceedings upon the judgments delivered in the Land Tribunals, etc.
