Sub: Transfer of officers belonging to the cadres of WBLRS and SRO- II.

Respected Sir,

The issue of transfer and consequent posting is always a delicate issue for any official whose service is under the precondition of transfer. The officers of the L&LR and RR&R Department are nothing different. The only difference is the regularity of the issue as per norms. Thus, on behalf of our officer cadre, I would like to request you to consider our point.

Sir, inspite of having a departmental transfer policy guideline, a good number of officers are awaiting to get transfer, preferably nearer to their home zones. A good number of the officers belonging to the cadres of WBLRS and SRO-II, are being posted away from their home zone for no less than five (05) years in succession. A list of a few such officers is enclosed herewith for your kind perusal.

It is an admitted fact that, all the officers cannot get preferable posting at the same time but a sensitive administration can maneuver the transfer-roster effectively.

We are agreed with the administrative compulsions in some cases, but nevertheless, the rest of the poor officers are looking at you. Among those, some deserve transfer on compassionate grounds such as crucial treatment of self and nearest kin, as well.

Sir, you may not even disagree with the fact that for running a smooth system for citizen centric service with inadequate staff strength, an unwilling horse is the 'Achilles' heel'.

It is even a fact that in some districts we have seen that some senior officers, who are capable to handle the workload of the district management with their experience mainly in law matters, are posted at the block level. This is a serious concern in defense of State interest at different judicial forum. An equilibrium may be maintained in this regard.
