Madam,

Most respectfully I draw your kind attention to the fact of the inordinate delay in promoting the SRO-IIs as a feeder to WBCS (Exe.) cadre vis a vis Jt. BDOs of P&RD Department.

SRO-II, Joint BDO and Assistant Canal Revenue Officers are feeder to the WBCS (Exe.) cadre. Since last decade the share of SRO-II as a feeder to WBCS(Exe.) has been persistently diminished. However, the meagre number of berths which are available to the SRO-II cadre of the L&LR and RR&R Department is being veritably denied by our department for some obscure reason intangible to us.

In spite of repeated request from the Public Service Commission, West Bengal our department has turned a deaf ear since 2016. It is also becoming difficult for PSC, West Bengal to keep a track and carry-over the earmarked vacant posts, year after year. This has also been expressed in the letter of PSC, WB under reference.

P&RD and the PAR Departments are working in perfect harmony and as a result the Jt. BDOs are smoothly being promoted to WBCS (Exe.).

The above figure clearly demonstrate the department's unwillingness and blockage creating hindrance to the cadre's career advancement and promotion of the SRO-IIs including SC & ST cadres. It definitely cuts a sorry picture if not of willful negligence of our department.

We simply fail to understand this step-motherly behavior of our department towards SRO-II cadres. The department has never came out with any tangible discourse or explanation as far, for this delay in this respect.

Side by side we attached the letters of P&RD and P&AR which clearly shows the efficiency in this regard and the eagerness of that department towards promotion of Jt. BDOs (vide ref:- 3 & 4).

This cadre has been the 'beast of the burden' and carried out dragging odd jobs in the most inhospitable terrains of our state.

Through, this submission, and on behalf of our association, I earnestly urge you to kindly look into the matter and resolve the deprivation of 93 SRO-II cadres in the waiting line of the 'to be promoted' SRO-II and the entire cadre down the line who had been robbed of four valuable years in their career.

The matter may please be treated as extremely URGENT.



Subject: Promotion to the posts in West Bengal Civil Service (Exe.) cadre from the feeder services against quota of the year 2018 under the Personnel & Administrative Reforms Department-- from S. R. O.-II feeder.

Sir,

I am directed to refer to on the subject noted above and to state that the Commission considered a total of 51(fifty one) (11SC & 3ST) vacancies from S. R. O.-II feeder against quota of the year 2017. Those 51(11 SC & 3 ST) comprised of 30(thirty) (7 SC & 2 ST) vacancies as carried forward from 2016 and 21(twenty one) (4 SC & 1 ST) fallen as fresh quota of 2017. The Commission could recommend only 26(twenty six) (7 SC & 2 ST) S. R. O.-II against quota of 2017 due to dearth of willing officers in normal zone of consideration. It is crystal clear that all the carried forward vacancies from 2016 could not be filled and those 21 as fresh vacancies of 2017 got also unfilled. Further, the Department, in its letter No. 1325-PAR (WBCS)/ID-115/05(Pt.II) dated 08. 11. 2019 declared 26(twenty six) (5 SC & 2 ST) vacancies in respect of S. R. O.-II feeder as fresh against quota of 2018. Hence the Commission finds that there are resultant 51(fifty one) (10 SC & 4 ST) vacancies which may be considered against quota of 2018 from S. R. O. -II feeder:-

(i)	Still unfilled of 2016	: 04 (1 SC & 3 ST)
(ii)	Fresh quota of 2017	: 21 (4 SC & 1 ST)
(iii)	Fresh quota of 2018	: 26 (5 SC & 2 ST)
Total as cumulative against 2018		: 51 (10 SC & 4 ST)

The Commission feels it a troublesome work for keeping records of the no. of vacancies which would be carried forward in different spells, year after year. The Commission, therefore, suggests to the Personnel & Administrative Reforms Department, the cadre-controlling authority to extend the zone of consideration by taking cases of 6(six) times officers to the above 51 vacancies against the year 2018 (eligibility as on 01.01.2018) as a special case so as to dispose all the backlog vacancies at a stretch. I am, therefore, to request you to arrange to decide in the matter at the earliest possible and convey the same to both Commission and Land & Land Reforms and Refugee, Relief & Rehabilitation Department for taking necessary action at their end. It is mentioned herewith that the zone of consideration should contain the cases of those S. R. O.-II who (i) were born on or after 02.01.1964 (ii) put in 6 years qualifying service as prescribed in recruitment rules as on 01.01.2018. The list must exclude those who (i) were promoted to/ expressed willingness for promotion to S. R. O.-I (ii) resigned from service etc. Unwillingness, D.P. drawn against officers are also to be noted in Remarks column of Annexure-II. A.C.Rs from 2013-14 to 2017-18 with I. C. in respect of willing officers will also be required.

Sir,

I am directed to refer to the Commission's letter No III/50-PSC/IP-82/2019 dated 22.02.2021
(copy enclosed) for filling up of the vacancies to the post in question against quota of 2018 from S.R.O.-II
feeder and to reiterate that no reply from the department in this regard has been received by the
Commission. It is observed that a residual part i.e. still unfilled vacancies of 2016 and the whole vacancies
of 2017 will be carried forward to those of 2018; a cumulative/detail account was shown in Commission's
letter under reference. The quota of S.R.O.-II against the year 2019 may be taken into consideration only
after disposal of their vacancies of 2018. I am further to add that the P. & A. R. department with its letter
No.1049-PAR(WBCS)/1D-115/05(Pt.) dated 08.07.2021 has announced the vacancies to the post in
question against quota of 2020. The S.R.O.-II are already lagging behind 2(two) years in the matter of
promotion. On account of dearth of willing officers in the normal zone of consideration, the Commission
has to carry-forward the unfilled vacancies to that of next year(s). I am, in the circumstances, to request you
to expedite in the matter of extension of zone as was proposed in the Commission's above letter and arrange
to take initiative and to move the Land & Land Reforms department for disposal of the cumulative
vacancies of the year 2018.

This may be treated as extremely urgent.

Further action in the matter will be taken on receipt of reply from the department.


