In terms of the above captioned subject and reference, I, on behalf of our association would like to express our grave concern for your kind attention.

It is reported in the very news that on 05/04/2024, a few numbers of miscreants appeared at the office of BL&LRO, Bhagwangola-2 and harassed the officials present therein and ransacked the government properties. It is learnt that a complaint has already been lodged at the local police station against the culprits. It is learnt that a group of people have gone there with some sort of grievances and that can well be resolved by the course of law; recourse to hooliganism is not the way at all. It is also learnt that no legitimate steps have been taken by the authorities responsible for maintaining law and order.
