Sir,

It is really painful to periodically report to your good self regarding assaults of BL&LROs and ROs in the districts.

On 28/08/2019 Sri Bikram Mookerjee, SRO-II & BL&LRO, Raghunathpur-I was severely assaulted by one Jiten Sukla alias Chika while exercising his duty to prevent illegal mining of minerals.

Within last couple of months such atrocities against BL&LROs and ROs have been regularly informed to your kind self. The district administration is suffering from '**Dhritarastra syndrome**'. The police had been far from being active and responsive.

The BL&LROs and BDOs are the soft targets of these lumpen plunderers. In Dhupguri the BL&LRO was about to be runover by a heavy earth mover. In Birbhum, BL&LRO Mayureswar-I was heckled. The plunderers and miscreants are out at large flexing their muscles.

On 29/08/2019, through out West Bengal the cadres belonging to SRO-I, SRO-II and WBSLRS Gr-I(RO) are lodging their protest by wearing black badges. On 31st instant, our association will organize a central programme for protest and demonstration, raising cadre demands and against atrocities in Moulali Yuva Kendra, Kolkata.

If the miscreants are not brought to the book, we will have no other recourse but to scale up our protest and raise concern.

The ecological imbalance that is created by such plunderers who are unauthorisedly quarrying minerals which are national assets, definitely calls for concern of the responsible institutions, parastatals and judiciary. The same is also occurring by illegal conversion of wet lands in and around Kolkata, which is of much concern of the National Green Tribunal.

The magnitude of such plunder and repeated assaults of Government officials and employees by such local mafias definitely calls for stern administrative action.

As the miscreants have been named in the FIR an early action is solicited.

Our association will have no recourse but to intensify our protest against such incidents in future.


