

N.B. Before coming into force of WBLRTT in the year 1998 land related grievances arising out of any proceedings or order passed by any Authority/Officer under the land related Acts were agitated before the transferred to WBLRTT and numbered as T.A. (Transferred Application). After 1998, land related disputes under specified Acts are being filed before WBLRTT as Original Applications& Land related matters under Hon'tle High Court at Single Bench by filing Writ Petition (WP), C.O. or C.R. and any order passed by Single Bench was appealed before the Division Bench of High Court. Pending Writ Petitions after 1998 were non specified Acts like Land Acquisition, Quarry permit / lease of Minor Minerals etc. before High Court as Writ Petitions.
