Guidelines framed regarding Settlement of the Government Water Bodies/Part vested Water Bodies etc.

In terms of this Department Memo No.381-GE(M)/1F-09/2020 Dated – 03/02/2022, a Departmental Committee has been constituted to explore the possibility of framing some guidelines and other feedback in the matter of settlement of Govt. water bodies / Part vested water bodies.

The following guidelines have been framed: -

- Data Base of all the Govt. vested water bodies / Part vested water bodies will be prepared. Spread sheet will be shared for updated status of settlement of the Govt. vested water bodies / part vested water bodies.
- Tender process for settlement of Govt. vested water bodies / Part vested water bodies from the District Authority level should be initiated at least one year ago from the date of expiry of the previous settlement.
- Settlement proposal complete in all respect along with the requisite documents containing in the
 cheek list should reach to this Dept. at least 4 months before the expiry of the previous settlement
 and specific comments, if any.
- 4. Date of execution of lease deed will be assumed as the date of handing over possession to the lessee.
- 5. Settlement period will be counted with effect from the date of execution of lease deed between the lessor and the lessee.
