Sub:- Working inoceedure in connection with reconstruction of lost /destroyed / damaged record of rights as per amendment schedule 'C' of the W.B.E.A.Rules.

RECONSTRUCTION of lost or destroyed or damaged finally framed and finally published record of rights according to the principles laid down in the amended schedule 'C' of the W.B.E.A.Rules will involve the following tiems of ework:

- (a) Preparation of draft record of rights on the basis of available materials .
- (b) Giving of opportunity to person or persons interested in such record of rights to inspect such draft record of rights and to file objectic
- (c) Giving of opportunity to person or person, who may file objection of being heard and after considering such objections and other document that may be filed by such person or persons and making the first record of right final with or without modification.
- (d) Furnishing of a certificates by the Revenue Officer concerning in so reconstructed record of rights certifying it to be a true copy of such finally published record of rights.
- (c) A formal proceding should be drawn up to proceed with the work of reconstruction . A specimen order sheet is enclosed. Proceedure to implement the above items of work may be followed as noted below itemwise.
- (a) There should not be any difficulty in this item because draft record of rights can be prepared on the basis of the Ist copy of record of rights by taking authenticated copies thereof from the J.L.R.O's office and other materials such as 44(i),44(2a) cases, requested through a notice u/s 57 in usual manner to arrange production of the original volumes of the 1st copy records of rights concerned with Rent Roll before the Revenue Officer for examination.
- (b) Draft record of rights as prepared, shall then be kept open for a month (to be specified by mentioning dates from & to) to give opportunity to the person or persons interested in such draft record of ights to inspect the same and to file objection, if any within the said period of one month by issuing notice u/s 57 to such interested person / persons only as this is a case of reconstruction of last finally published record of rights and not of preparation of any record of rights and the J.L.R.O. concerned (A specimen of the notice is enclosed).

There is no necessity of proscribing any form for filling objection interested parson/ persons may file objection in plain papers as was done in task of application u/s 45. As the reconstruction of lost record of tights is required for no fault of the parties there should not arise the question of levy any court fee on this account. While taking up hearing of the objection so filed, notices should be issued in usual manner only to the persons who have filled objections, the persons who may be mentioned in objection petitions as parties to the cases and the J.L.R.Os concerned for hearing and adduce evidence, if any, documentamy or oral and not to any other person unless there is specific requirement for issuing notice to such other person. No opportunity of filling any appeal against the decision made in the objection cases can be given to any of the parties because as alweady mentioned, this is a case of reconstruction of lost record and not that of preparation any records afresh and there is also no provision in the amended schedule for such purpose.

d) After disposal of all the objection filed, the Revenue Officer shall make such draft record of rights final with or without modification by affixing a certificate on the body of the record of rights so finally reconstructed as per specimen noted below.
