On behalf of our Association viz. Association of Land and Land Reforms Officers, West Bengal, I submit herewith eight copies of Memorandum containing Part I and Part II to differentiate the contents thereof.

Part I of the Memorandum deals with our views to adopt the principle of pay determination, date of effect, method of pay fixation within the revised pay Scale in conformity with central 6th Pay Commission and central Govt.'s decisions thereafter; it also deals with suggestions in respect of major allowances and other fringe benefits including retirement benefits which are put forward also by the State Co-ordination Committee in general.

Part II of the memorandum deals with problems and positions with specific issues relating to the cadres viz. i) West Bengal Sub-ordinate Land Revenue Service Grade I, II) Special Revenue Officer - Grade II and iii) Special Recenue Officer, Grade I. : Agro based society – nature of unequal distribution of land – planning for removal of structureal anomalies – major changes in last three decades – enhancement of self respect of rural poor.

Pivotal role of three cadres representing our Asson – a share of the glory of successful Land Reforms work along with long cherished peasant movement and the political will of the State Govt.

Appreciating gesture of the commission to consider the issue of efficiency in administration —question of efficiency switched over to the junior strata of functioneries—It needs to be discussed encompassing all categories functionaries, irrespective of status.

Works in connection with land acquisition, Kolkata Land Revenue, Kolkata and Howrah Thika Tenancy are gradually becoming complex.

Efficiency and Social accountability of the Cadres relates to educational qualification and selection through P.S.C., W.B.—nature of responsibility: administrative, financial, technical and quasi-judicial—far reaching effect in Socio-economic arena. (Para 3.1 to 3.6)

Present Structure of Pay and condition of service with proposals and suggestions.

Design of existing set up:

- a) District level headed by DL & L.R.O.
- b) Sub division level headed by S.D.L. & L.R.O.
- c) Block level headed by B.L. & L.R.O.
- d) Gram Panchayet level headed by Revenue Inspector.

Existing method of recruitment:

- a) W.B.S.L.R.S. G.r-I -67% direct recruitment through W.B.C.S. and other allied services Exam (Group C) conducted by P.S.C., W.B. -33% through promotion from the feeder (Revenue Inspector)
- b) S.R.O.-II by means of promotion exclusively from W.B.S.L.R.S. Gr. I
- c) S.R.O-I-by means of promotion excluively from S.R.O.-II.

Existing structure of Pay:

- a) W.B.S.L.R.S. Gr. I Scale No. 14 (Rs. 5500/- 11,325/-)
- b) S.R.O. II Scale No. 15 (Rs. 6000/- 12,000/-)
- c) S.R.O. I Scale No. 16 (Rs. 8000/-- Rs. 13,500/-)

After long deprivation scales of pay for W.B.S.L.R.S. Gr. - I and S.R.O. II have been upgraded vide G. O. No. 5238F dated 28.07.2008 from Scale No. 12 and Sclae No. 14 respectively.

(Para 4.1 to 4.4. (d) (xii)

Existing promiton policies & related issues – Porposals and Suggestions for suitable changes:-

As per exising promtoin Rules W.B.S.L.R.S. Gr.-I are to get promotion to the rank of S.R.O.-II after 5 yrs'. of successful service, but in reality it takes 12/14 years (recent development)

Point of deprivation lies in the fact that they get promoted from Scale No. 14 to Scale No. 15, although Joint B.D.O., haveing the same recruitment method are directly promoted to scale No. 16.

S.R.O.-IIs are feeder to W.B.C.S. (Ex.) to the post of S.R.O.-I – As per promotion Rules they are to get pormotion to the rank of S.R.O.-I after completion of 3 years of successful service and to the rank fo W.B.C.S. (Exe.) after completion of 6 years of successful service – but the reality in bleak – Many of the S.R.O.-IIs fail to avail promotional prospect due to age bar (54 years) – due to shortage of berths for S.R.O. - I, Promotion prospect for S.R.O. - II to the rank of S.R.O.-I is meaningless – As such many of the S.R.O.-IIs retire from service without any promotion. Our Suggestion – Increase of the higher post in the rank of S.R.O.-I is very essential. (Para 5.1 to 5.5)

Specific Suggestions for fitment by proposed S.R.O.:

- i) Formation of S.R.O. (New nomenclature) through merger of S.R.O.-II and S.R.O.-I such merger is imperative for total interest of admninstration and career prospects of the cadres.
- ii) Promotion of W.B.S.L.R.S Gr.-I to the rank of S.R.O. or Special Revenue officer (after merger) in Scale No. 16. (Pay band 5, with Grade pay of Rs. 5,400/-)
- iii) S.R.O. should have sufficient avenue for promotion to Scale No. 17 and Scale No. 18 (Pay band 5, with grade pay of Rs. 6,300/- & 7,200/- respectively) (Para 6.1 to 6. G)

Other Related suggestion: (i) Nomerclature of W.B.S.L.R.S.-Gr. would be R.O. (Revenue Officer) in Scale No. 14 (Pay band 4 with grade pay Rs. 4,700/-)

- (ii) R.O.s would exclusively be feeder of S.R.O. no direct recruitment in S.R.O.
- (iii) M.C.A. benefit would be available for all irrespective of scale or band.

Special Pay / allowance:

Special pay of T.A. should be at least Rs. 100/- from existing Rs. 40/-—Special Pay for E.O. (L.R. Deptt.) should at least be doubled from existing Rs. 150/- (Para 7.1 to 7.2)

Other Fringe Benefit:

Same suggestion as enunciated in Part - I of Memorandum submitted by State Co-ordination Committe (made part II of our Memorandum) (Chapter VIII)
