Sub: Filling of vacancies and subsequent posting in respect of posts in WBLR Service and in the post of SRO-II.

With grave concern, I, on behalf of our association, would like to invite your kind attention to the following facts -

- 1. Since the inception of the WBLR service comprised with the cadre of Joint Director, Deputy Director and Assistant Director, though your good office have taken initiative to fill the residual vacancies, as on date a good number of vacancies in the post of Joint Director, Deputy Director and Assistant Director are still lying vacant which certainly affects the citizen centric services provided by us.
- 2. Very recently, in order to maneuver the posts of Deputy Director. Assistant Director and SRO-IIs of the department, two successive transfer orders vide No. 76-Estt./1E-01/2024 & No. 77-Estt./1E-01/2024 dated 05.01.2024 have been published from your good office accordingly. Surprisingly, to our utter dismay, we have seen that both the orders have been kept in abeyance vide your good office No. 104-Estt./1E-01/2024 dated 08.01.2024 and till date we have no information as to the fate of those two orders.

Now, it is a well known fact that the General Elections to the Lok Sabha is knocking at the door and we are apprehending that the poor officers who are anxiously awaiting to get much coveted transfer to their home zones or nearer to in this respect, may fall victim to the situation.

- Further, the preparation and publication of Cadre-Schedule as the backbone of the WBLR Service is still in dark.
- 4. This is very much pertinent to mention here that since the Notification vide No. 2001-Apptt/1E-08/2017 dated 22/07/2022, no further order of promotion from the post of Revenue Officer to the post of SRO-II has been published by the department in spite of having substantial number of vacancies in the post of SRO-II. Thus, on behalf of our association, I would like to humbly reiterate once again that a sizeable number of vacancy still remains in
