Sub: <u>Inordinate delay in transfer of SRO-II and ROs and promotion</u> to the post of SRO-I from SRO-II.

Sir,

Learning from reliable source that the long pending transfer of SRO-II & ROs from the districts have been kept in abeyance due to the purpose of DUARE SARKAR.

They were supposed and expected to be transferred in the month of November 2020.

However, we could find that about 500 WBCS (Exe.) Cadres were transferred while the programme DUARE SARKAR is going on. Are the BL&LROs and ROs so indispensible that they cannot be transferred though they are only attached to a single programme of 'Krishak Bandhu'?

We are aware that after the direction of the Hon'ble Supreme Court, The municipal election as well as the election to the State Assembly as knocking at the door. This may not be expected to become another hurdle again.

Hence, we urge to you kindly issue the direction of transfer of the both the cadres at the earliest. Further, we also seek to consider the stay of ROs in B-zone to be 4 years instead of 5 years.

Further, the inefficiency of our department has been expressed again by not being able to promote the SRO-II cadre to SRO-I within 31.12.2020 which could have been done. This will cost the cadre one increment which is an economic loss for no fault of their own.
