**Criminal Proceedings**

Respected Madam,

With reference to above three letters, we would like to draw your kind attention to the insouciant approach of your good office in preserving and communicating the valuable documents/ records of SRO-Is, SRO-IIs & ROs like ACR/SAR and Asset Statements.

Every year, the department as well as the Directorate wakes up after puja holidays to prepare the list of eligible SRO-II awaiting promotion to SRO-I as well as to WBCS(Exe)

After sustained struggle and persuasion the loss of ACRs could be restricted due to introduction of digitization of the documents in form of SAR.

The procurement of reports of DP/VC in ISU and the other wings from all the districts is a time consuming and tedious task, which ought to have been initiated much earlier. Kindly, note the delay under ref (ii).

Suddenly, a new category of criminal proceeding has been added, instantly. This proves the fact that how much oblivious the department is, with respect to the departmental cadre, as because, not a single criminal case against a government employee can be registered without the knowledge or explicit permission of the authority. Actually, this sordid affair has emanated from exposing and subjecting the quasi-judicial authority of RO and SRO-II to the executive or police action by instigating the public and lodge FIRs against any decision of RO/SRO-II flouting the norms and laws and protections of the RO/SRO-II.

If there really exist any criminal proceeding it must have been recorded by the authorities. We find it another pretext to delay or deny the promotions to the eligible SRO-II awaiting for promotion to SRO-I cadre.
