Sub: Fake Deeds, Law Clerk hegemony and criminal procedures against RO/BLLRO within ISU.

Respected Madam,

We have no other recourse but to seek your kind attention to the serious problems faced by BLLROs/ROs at the block levels with respect to the each and every issue as mentioned above.

We welcomed and had diligently laboured for computerisation of the land records, though there is lot of scope for improvement of the software to save the sanctity of the record of rights from any kind of manipulation from inside or outside. However, the immense pressure borne by the BLLROs/ROs particularly during covid pandemic renders disposal of nearly about crore of mutation cases along with huge conversion cases through office as well as “Duare Sarkar” mode. We feel that the Department should highlight this achievement of the cadre before the appropriate forums as an instance.

We find that inspite of the veil and protection provided to the officers under section 58 of the WBLR Act, 1955 as well as relevant provisions of IPC and Cr. P.C., there is a strong propensity to file FIRs against BLLROs/ROs, or to harrass in the name of investigations. There is also a concerted effort to malign the cadre within the administration as well as by the media, shifting the onus of the fake deeds and fake documents over the poor BLLROs/ROs.

Never it is found that the registration authorities have ever been challenged or questioned by anybody. Presently the e-registration website has come to somewhat help the BLLROs/ROs. As per departmental circulars, the BLLROs/ROs have been asked to follow the legal heir certificates from the elected public representatives, but issuance of any wrong certificates or declaration is usually not questioned.

The Law Clerks, empowered by the government notification, is creating a havoc at BLLRO levels. The entire blame of their misdeeds is shifted to BLLROs. Recently the incidence in Purulia is a great revelation which we do not like to elaborate for the sake of the dignity of the government.
