Sir,

From the reference of PSC, West Bengal above, several facts have come to light, whereby most of the serious issues had been agitated and raised by our association in the past.

The PSC states that there are 51 vacancies from SRO-II

- (i) Still unfilled vacancy of 2016:- 4
- (ii) Fresh quota of 2017:- 21
- (iii) Fresh quota of 2018:- 26

Total as cumulative against 2018:- 51(10 SC & 4 ST)

The cardinal issue of unfilled vacancies is due to sending the names of the unwilling candidates (SRO-II) or counting them within the zone of consideration. We hail the decision of increasing the zone of consideration to six times of vacancy. Yet, there will remain a gap between demand of SRO-II over supply. Only and only road is to consider the names (6 times) amongst the willing candidate (SRO-II) in the gradation list leaving aside the unwilling SROII s.

The unwilling SRO-IIs, though figuring in the gradation list, should not be considered in person or as numbers in the zone of consideration. This has resulted in gluttony of SRO-IIs who are eligible to get promotion, but simply gets left out due to computation method of zone of consideration. Even with six times

multiplier, the result will be same. The authority has time and again failed to realize the situation and the indifference of a certain section of SROII and on the other hand the craving of other eligible SRO II to get promoted to WBCS(Exe.) in due time. They are missing the bus for no fault of their own.

By the resolution of creation of LR Service without formulating the rules and modalities of who will be eligible to be induced in the proposed LR Service, the cadre stays at askance to the weird situation of not getting a chance to be promoted to WBCS(Exe.) or to be induced into the LR Service.

Not getting into the nitty-gritty of the conundrum, we simply demand that the names of the SRO-IIs who are willing and eligible be sent to PSC, West Bengal to the tune of  $51 \times 6 = 306$  willing SRO-IIs for promotion to WBCS(Exe.) cadre. Otherwise the train will be running with vacant berths while the eligible passengers remain stranded in the platform.

Our views regarding constitution of the LR Service which definitely based on elimination of any discrimination or deprivation to any existing cadre of WBSLRS Gr-I, SRO-II vis-a-vis the existing available channels and opportunity of career advancement through promotion. But, that chapter will be raised separately.

Hence, at present we urge to kindly send the names immediately to Public Service Commission, West Bengal as per our suggestion, in order to establish the natural justice to the poor cadres of SRO-II and save them from any further deprivation.
